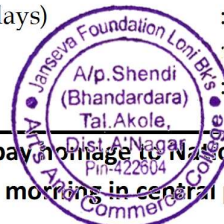

6. The Trustees are at liberty to spend or utilise either the income or any part of the corpus of the Trust Funds for making payment under any one or more of the purposes and objects specified in Clause 5 herein above in such proportion and in such manner as they may think fit and proper and shall be entitled to accumulate the unapplied income if any of the Trust Funds and invest the same and the resulting income thereof in any of the investments hereby authorised and may apply the accumulation of any preceding year or years in or towards any one or more of the purposes and objects specified in Clause 5 hereof in the same manner as such accumulation might have been applied had it been income arising from the Trust Funds in the current year.

7. The appropriation of the income or corpus of the Trust Funds towards one or more of the charitable objects mentioned in Clause 5 shall be made by the Trustees from time to time.

8. In carrying out the objects and purposes set out in Clause 5 above, it shall be lawful for the Trustees to carry them out independently or to donate or subscribe the income or corpus of the Trust Funds or any part thereof on such terms and conditions as the Trustees may deem fit in their absolute discretion to any other Trust or Trusts institutions panchayat local board or municipality or to work in collaboration with such trust or trusts institutions panchayat local board or municipality and to share expenses or to fund new Trust provided always that the benefits under the Trusts shall not be restricted to any particular community.

9. The Trustees may at any time invite and receive or without such invitation receive any voluntary contribution or contributions either from the Settlor or from the Trustees or any one or more of them or from any other person or persons or from associations of persons or from institutions or trusts or firms or companies or from any member or members of the public by way of donation legacy or otherwise including any share right title or interest in any immoveable property or any share in a firm or either solely or jointly with any person or person or firm or company or corporation for all or any of the charitable objects mentioned above provided that they are not inconsistent with the provisions contained in Clause 5 of these trusts. 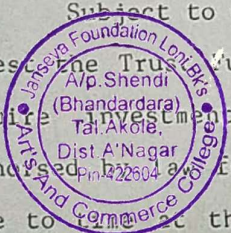

Provided that terms of acceptance thereof shall not in any way be inconsistent with or repugnant to the objects of these presents.

11. The Trustees shall be entitled from time to time to open maintain and operate banking account or accounts in the name of the Trust or in the names of two or more of the Trustees with such Bank or Banks as they may from time to time decide and may at any time pay or cause to be paid any moneys forming part of the Trust Funds or ~~the~~ income to the credit of any such account or accounts either by way of fixed deposits or current or any other account as the Trustees may deem fit. Any such account may be operated by two or more of the Trustees jointly.

12. Subject to the provisions hereinabove, the Trustees shall invest the Trust Funds and all moneys in their hands which may require investment in securities or modes of investment authorised by law for investment of trust funds and shall have power from time to time to exercise their discretion to vary any investments and

It shall be lawful for the Trustees to pull down renovate re-build adopt improve and to develop or repair and immoveable properties comprised in the Trust Funds and to expend thereon such moneys out of the Trust Funds or the income thereof as they think fit. The Trustees shall also be entitled to enter into any agreements or covenants with owners of or person interested in any other properties whether restrictive or otherwise and whether for the benefit of the properties comprised in the Trust Funds or such other properties as they may in their absolute discretion think fit from time to time. The Trustees shall have power to insure any premises comprised in the Trust Funds against loss by fire, lightning or civil commotion or other risks or losses as the Trustees may think proper from time to time but no liability shall be attached on the Trustees or any of them by reason of any property remaining uninsured in any way. The Trustees shall also have the power after paying all rents rates taxes and other out-goings and expenses out of the rents and profits of any immoveable properties to set aside out of the balance thereof from time to time such sums of moneys as the Trustees consider proper to meet the expenses of heavy repairs or by way of depreciation or sinking fund and to utilize the same and the income thereof for heavy repairs or for rebuilding or for reinstating the immoveable properties or erecting new buildings and in the meantime to invest the same in investments authorised by these presents.

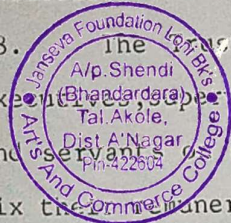

The receipt of any one of the Trustees for the rent or other income of the Trusts Funds or for any document or title relating to any properties or securities comprised in the Trust Funds and/or for any other moneys paid or for any income of the Trust Funds or any documents of title or securities papers or other documents shall be sufficient and shall effectually discharge the person or persons paying or giving or transferring the same from being bound to see to the application or being answerable for the loss misapplication or non-application thereof.

Such nomination may also be made by a will and shall be as effective as a nomination made by writing addressed to the Trustees. The nomination so made shall become effective upon the death or voluntary retirement as the case may be of the incumbent permanent Trustee and Chairman. In the absence of any such nomination by the said Shri.Vikhe or his successor/s for any reason whatsoever and under any circumstances, it shall be lawful for the continuing Trustee or Trustees for the time being of these presents to appoint any one of them to be the permanent Trustee and Chairman. The said Trustee shall be the chairman of the Trust and preside over the meetings. In case of any difference of opinion amongst the Trustees with regard to the execution of powers herein contained or with regard to the interpretation of these presents or anything to be done or omitted to be done in relation thereof the opinion of the majority shall prevail and in the case of equality of the votes, the Chairman of the meeting shall have the Casting Vote.
