#### **Introduction**

#### **Alternate sources of energy and energy conservation measures**

LED bulbs, tubes etc. are used in the college to save electricity. Power supply should be kept uninterrupted 6k.w capacity generator has been installed. UPS systems have been installed for office, examination department, principal's room, IQAC in the college. The institute is trying to provide non-conventional energy sources in addition to conventional energy sources. Sensor based tube lights have been installed in the college so that they are used only at the time of need.

The college building is located in a cold region and has been constructed with special care for ventilation so the air condition is very less. .

While buying any electrical item for college, emphasis is placed on buying star certified items like ceiling fan, wall fan, air conditioner, lab equipment, fridge etc.

Energy efficient monitors are used in computer labs and workplaces to save electricity.

There are places where electricity is not consumed and notifications about low electricity consumption are displayed. A main switch has been installed in case of power failure to the entire college.

### **Management of the various types of degradable and non-degradable waste**

The college has different dustbins for different types of waste, such as biodegradable, recyclable and non-degradable. Green, blue and red bins have been provided across the campus for the collection of solid waste generated at different sources in the college. Organic waste is disposed off in compost pits and processed and reused as manure for the plants and trees inside the campus. Plastic usage is prohibited on campus so as to create a plastic-free zone.

For liquid waste management, water transport systems are regularly inspected. Leaks in pipes, taps, valves are repaired immediately.

To ensure clean and safe potable water supply, the college has installed a water filter with a capacity of 100 Lit/hr. Leaking water from water tanks is used for plants.

### **E-West**

The PRES has centralized scheme to collect the e-waste from various institutions. Furthermore, the PRES takes the necessary action on the collected e-waste.

### **Water conservation**

Our college is located in a very remote hilly area. Bhandara in Akole Taluka and surrounding areas receive heavy rains during monsoons. That is why this area is called Cherrapunji in Ahmednagar district. The water falling on the roof of the college is stored in a Syntax tank of 1000 liters capacity. This water is fed to the plants or even used for daily use.

### **Green campus initiatives**

Tree plantation is organized in the college from time to time. Padmashri Dr. On the occasion of the birth anniversary and death anniversary of Vitthalrao Vikhe Patil and Padmbhushan Dr. Balasaheb Vikhe Patil, tree plantation is done with the cooperation of the organization and the villagers. Saplings are provided to each college from the office of the institute. Trees are also planted in adopted villages for special winter camps through the College's National Service Scheme and

Student Development Board. A sapling is given to the chief guests and lecturers as well as the contestants of the program organized in the college.

**Disabled-friendly, barrier free environment**

A ramp has been provided for the disabled students taking admission in the college. A counseling room has been set up for such students. International Disability Day is celebrated in the college so that these students can get education like other students. At that time the guidance of experts is organized. Wheel chairs have been provided for these students. Toilets with commodes are provided for disabled students and staff.

# Waste Management Policy

## Introduction

College of Arts and Commerce, Shendi was established in 2007 under PravaraJanaseva Foundation. The college is located in a rural area of Ahmednagar district of Maharashtra and is catering to the educational needs of boys and girls in the surrounding 40 villages. The college has a green campus of around 5 acres equipped with state-of-the-art facilities for teaching and learning. The college is permanently affiliated to Savitribai Phule Pune University, Pune and the institution is committed to transform lives and serve society through excellence in teaching, learning, cultural enrichment and outreach programmes. The institution provides sustainable and holistic waste management, which is essential to reduce environmental footprint and provide a safe and healthy environment for teaching and non-teaching staff and students. The institution ensures that all waste on campus is disposed of responsibly using proper waste segregation systems and converted into eco-friendly products if possible.

## Policy Statement

The college applies “solid, liquid and e-waste principle” in delivery of its waste management system. College implements waste handling procedures. The solid/liquid waste generated in the campus is managed and handled in accordance with the compliance criteria and procedures laid down in the Municipal Solid Waste (Management Handling) Rules, 1999, published as per the notification of the Government of India, Ministry of Environment and Forests to minimize, reuse and recycle waste products. . No. S.O.783 (E) dated the 27th September, 1999 in the Gazette of India, Part II, Sub-Section (ii). It is a legal requirement for all those generating, depositing or disposing of any type of hazardous/radioactive/chemical waste to comply with various regulations under national and international environmental protection laws.

## Policy Objectives

- Ensuring that waste management is carried out in accordance with all waste legislative requirements, including monitoring and planning for future legislative changes and mitigating their impact.
- To provide clearly defined roles and work to facilitate the reduction, reuse and recycling of waste disposed of in a cost-effective manner.
- Supporting environmental awareness to increase and motivate waste reduction, reuse and recycling.
- To ensure safe handling and storage of waste in the college campus.
- Maintaining environment with minimal plastic usage.
- To promote a holistic approach to waste management in the campus.

## Organization and Management

- Organic farming.
- Non-biodegradable waste is further segregated and disposed through Grampanchayat garbage vehicle on a routine basis.

## Liquid Waste Management

Responsibilities and organizational arrangements for the liquid waste management policy lie with various personnel in the college.

- Principal
- HOD's
- One faculty member from each department
- Student representatives.

### **Waste Management Methods:**

#### **Solid Waste Management**

- Every day all academic buildings and other premises in the campus are cleaned by the maintenance department.
- Two bin systems is adopted for waste collection one biodegradable and one non-biodegradable.
- Biodegradable waste is converted into vermin composting and used in toilets etc., discharged as sewage in proper drainage facility and accumulation is avoided.
- Liquid wastes from chemistry laboratories are piped into soak pits.
- E-waste management
- Optimum utilization of all electronic equipment through repair.
- Unused and irreparable waste is disposed of by sending it to Pravara Rural Education Institution.

# WATER CONSERVATION POLICY

## **Introduction**

The primary objective of the water conservation policy is to provide safe and clean water throughout the campus. The college is implementing water efficient practices. Student and staff engagement play a key role in our water sustainability strategies.

The college is committed to more equitable use of water and is working towards making the sector water sustainable. This has been achieved by using water efficient fixtures, rain water harvesting methods.

Water is stored in a storage tank by Saipan through Gram Panchayat Chichondi to supply water to the entire campus area. The college is equipped with overhead tanks for storage and uniform distribution of water in the campus area. The college immediately repairs leaks and performs necessary periodic maintenance to prevent water wastage.

### **1. Rain Water Harvesting:**

The college is situated in a high rainfall area but after the end of the monsoon some measures are mainly taken to overcome water scarcity and ensure permanent water supply. The roof area of the building is 957 sqm. Water is collected from the roof. A 1000 liter capacity is stored in a Syntax tank located on the south side of the building. Rainwater harvesting has benefited a lot and helped in overcoming water scarcity.

### **2. Maintenance of water bodies and distribution system in college campus:**

Water bodies are regularly maintained to ensure sustainable, consistent, safe and adequate water supply to the campus. Water is distributed through a well-equipped system of pipes. Drinking water facility is provided through filter with a capacity of 100 liters per hour. Another set of distribution pipes is used for all other uses. Using good quality plumbing fixtures reduces water wastage to a great extent. Scheduled inspections of machinery are carried out regularly in the campus. All water sources and distribution systems are maintained.

# Green Campus Policy

## **Introduction:**

## Green Campus initiatives in the campus

### 1. Restricted entry of automobiles:

Vehicles should be parked at parking area to reduce noise and air pollution. Honking of horns should be prohibited in the college premises and speed limit should be restricted to 10 km/h.

### 2. Bicycles/Battery Powered vehicles:

As the college is located in the rural area, most of the students prefer bicycles to commute. College has set up bicycle stands as a part of discipline and security. Staff and students are to be encouraged to use e-vehicles.

### 3. Minimum use of Plastic:

The use of plastic in campus is minimized by creating awareness among staff and students through orientation by authorities and display boards in the campus. Use of polythene bags less than 80 micron thickness is prohibited in the campus.

### 4. Landscaping with trees and plants:

The campus development committee is constituted to look after the development, maintenance and monitoring of the campus. The botanical garden has endangered, endemic and medicinal plant collection. An adequate financial support is provided for proper care and maintenance of greenery in the campus. Landscaping of the college is worth seeing and reflects aesthetic sense. Utmost care is taken to develop and maintain landscaping by trained gardeners and supervisor.

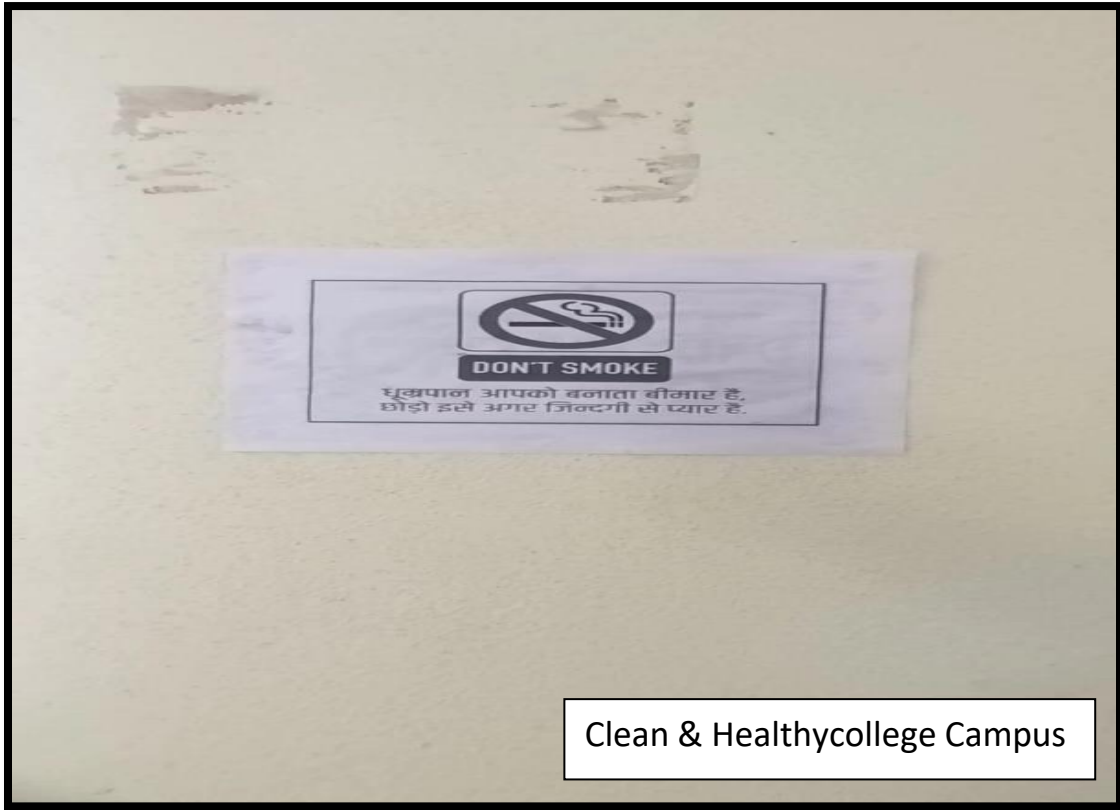

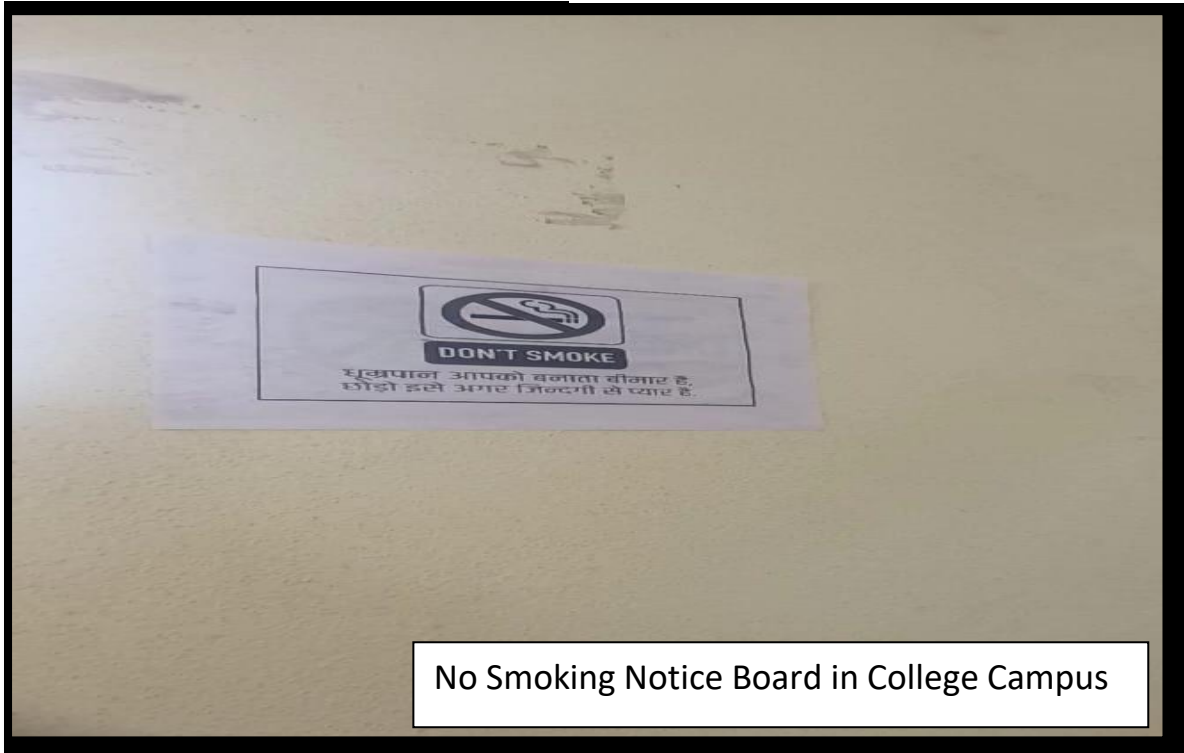

## POLICY ON PLASTIC BAN

### Context:

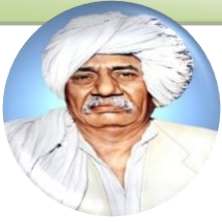

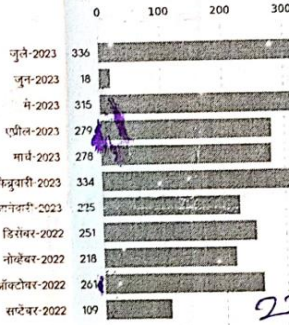
